High Tech Products S.R.L., declares, with regard to the fulfillment of the obligations provided for by the European Regulation 1907/2006 REACH, that as a downstream user of substances, mixtures and articles and manufacturer of articles not intended to release substances during foreseeable use, it is not subject to the obligations of pre-registration and registration of substances provided for manufacturers and importers of substances and articles intended to release substances during use.

H.T.P. High Tech Products S.R.L. has therefore worked to fulfill its obligations, namely:

- check with its suppliers whether the items supplied contain SVHC substances from the "candidate list" above the legal threshold (0.1%p/p).
- verify with its suppliers that all substances as such or present in mixtures subject to REACH have been registered or pre-registered by them (or by upstream subjects) according to REACH.
- verify that the substances used in the manufacture of its products are used under the conditions of use for those substances as such or contained in mixtures.
- in the event of non-compliance with one of the previous points by a supplier, find viable reach-compliant alternatives in order to ensure continuity of supply.
- on the basis of the information received, evaluate the possible presence of SVHC substances in the products supplied to the customer.

H.T.P. High Tech Products S.R.L. therefore guarantees continuity of supply with regard to the products purchased by you and all the products in its catalogue and declares that they comply with the REACH Regulation.

Based on the knowledge currently in our possession, the articles placed on the market contain in concentrations above 0.1% by weight and less than 3.5% by weight, the substance "Lead" identified with CAS: 7439-92-1 and EC: 231-100-4, included in the Candidate List of SVHC substances updated by ECHA periodically and available on the website https://echa.europa.eu/candidate-list-table.
